Please verify your industry requirements or check with your employer or EFR First Aid at Work Instructor whether CPR refresher training is required within a year or less (some industries require refresher training every six months). Likewise, workplace first aid refresher training is required by Workplace Health and Safety and you should check the requirements for your industry in your State or Territory (commonly, workplace first aid refresher training is due every three years).

Accidents and illnesses can happen every day. Should you need to use your CPR and First Aid skills, we would like to hear from you. Sharing your story will encourage others to use their skills and provide assistance in emergency situations.
